- D. Draft Ordinance 11-01 – Animal Control
  - 1. A draft of the Ordinance was presented to Council for their perusal and suggestions for additions and/or changes.

- a. Upon those recommendations, an Ordinance will be presented for a first reading May 17<sup>th</sup> at the next meeting.
- E. Mayor Behling informed that Ted Kabelitz had requested to have his property annexed to the City of Lakeview in order to facilitate the addition of Dauphine Lane as a City Street, per the conditions presented to Mr. Kabelitz by Planning and Zoning.
