

ORDINANCE 00-07

TITLE: AN ORDINANCE PROHIBITING THE DISPLAY OF MERCHANDISE FOR SALE, RENT, OR LEASE ON THE EXTERIOR OF ANY BUSINESS PREMISE, TENT, LEAN-TO OR SHED, WITH SOME EXCEPTIONS.

SEC I: WHEREAS, THE CITY OF LAKEVIEW, BAXTER COUNTY, ARKANSAS IS DESIROUS OF MAINTAINING A CLEAN, WHOLESOME, UNCLUTTERED ATMOSPHERE AND APPEARANCE, AND WHEREAS, THE OUTSIDE DISPLAY OF MERCHANDISE FOR SALE, RENT, OR LEASE SEVERELY DISTRACTS FROM THIS GOAL:

SEC II: THEREFORE, THE OUTSIDE DISPLAY OF MERCHANDISE FOR SALE, RENT, OR LEASE IS HEREBY PROHIBITED.

SEC III: EXCEPTIONS: THE FOLLOWING ARE CONSIDERED EXCEPTIONS:

1. ALL OUTSIDE VENDING MACHINES IN USE AND GOOD WORKING ORDER
2. AUTOS, TRUCKS, TRACTORS, MOWERS, TRAILERS, BOATS, AGRICULTURAL MACHINERY AND EARTH MOVING MACHINERY
3. RUMMAGE SALES BY A HOUSEHOLD OR NON-PROFIT ORGANIZATION, NOT MORE THAN 3 DAYS IN DURATION NOR MORE THAN 2 TIMES A YEAR
4. FOOD AND/OR DRINK STANDS ERECTED BY NON-PROFIT ORGANIZATIONS SOLELY FOR SPECIAL EVENTS
5. CRAFT AND OTHER SALES STANDS ERECTED FOR SPECIAL EVENTS FOR A LIMITED TIME AND WITH CITY PERMIT.

SEC IV PENALTY: VIOLATION OF THIS ORDINANCE, UPON CONVICTION SHALL BE PUNISHABLE BY A FINE OF NOT LESS THAN \$25 PER DAY NOR MORE THAN \$100 PER DAY. EACH DAY BEING CONSIDERED A SEPARATE OFFENCE.

SEC V: EMERGENCY CLAUSE: SINCE THE APPEARANCE AND WELFARE OF THE COMMUNITY IS INVOLVED AN EMERGENCY IS HEREBY DECLARED AND THIS ORDINANCE WILL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS APPROVAL AND PASSAGE.
