1. List various communication strategies used in your school to provide additional information to parents and to increase parent and family engagement in supporting classroom instruction.

- The school will distribute a weekly newsletter to parents that is developed with participation of the parent-school organization, principal, staff and parent volunteers. It includes school news, a calendar of school activities, and parenting tips related to school achievement such as homework tips, organizational skills, and study skills.
- Parents can access their child's grades by logging into Eschool (HAC). Parents may use e-mail to communicate with members of the school staff.
- Each teacher will send home a folder containing student papers and work samples each week.
- Teachers and parents will be asked to sign the student assignment book daily and send it back to school.
- Teachers will routinely contact parents on an individual basis to communicate about their child's progress as needed.
- The school will provide parents progress reports/report cards every four weeks with information regarding their child's academic progress and upcoming classroom and school events.
- The school will send parents a letter that explains their child's test results and standardized test scores.
- The school will offer parents a special meeting each year on the school's approach to school improvement.
- The school will use the student handbook, school Web site, and parent meetings about the Schoolwide Title I Plan and how to get a copy upon request.

- The school will use Facebook, Instagram, and Twitter to update parents on building wide events.
- The school has HAC (Home Access Center) for parents to utilize in order to keep up with student grades.
- A digital sign with important dates and information is out front of the school for parents/families.

2. List the proposed parent meeting, conferences and activities regularly throughout this year and the dates providing flexible meeting times that you have planned to increase parent and family engagement and build staff and parent capacity to engage in these types of efforts. - Teachers will hold conferences individually with parents of children in their classrooms. Parents will be given a summary of the student's test scores and an explanation of the interventions teachers are using to assist the child in reaching achievement goals. Parents will be asked to engage in discussion of how they can support these efforts. Parents will also be given suggestions for coordinating school-parent efforts and explanations of homework and grading procedures.
- The school will offer parents a special meeting each year to provide an explanation of the statewide assessment system, standards, and other accountability measures.
- Parents will receive a STAR reading report at the fall and spring conferences. This report will also provide suggestions so that they may help in increasing reading levels.

3. How will your school provide information to parents about volunteer opportunities (must include state mandated parent training)?

- The school will provide opportunities for parents and community members to support the instructional program through such programs as Reading Buddies, tutoring, and special friends.
- The school will provide a list of volunteer opportunities and solicit ideas for other types of volunteer efforts during orientation of parents. PTO will explain the requirements to parents and encourage them to become involved in the school. Brief training sessions will provide
