- The school will work with Head Start and area colleges to help provide a smooth transition from one level to the next. OUR Head Start regularly comes to the school for breakfast, lunch, and attend special programs when appropriate. We try to ease the transition from High School to College by attending college days at local colleges, hosting college/trade school reps, military recruiters and by hosting financial aid workshops. During interventions, Seniors work on life skills such as: Career Research and personal finance planning. We attempt to keep parents informed of procedures and related activities by posting events/activities to the school webpage, social media. the school sign and by sending messages via REMIND.

Parents will receive 2 books (1 fiction/1 nonfiction) and a parent information sheet, instructions about how to use the packet, Creativity Activity: a hands-on craft project Imagination Activity: encourages imaginative play, writing, or drawing and a Get Real Activity: focuses on real-world experiences for parent and child. A Parent survey will also be included.

 gave us an updated view on poverty and how parents respond to school.
